Enrolment Policy

WYNDHAM COLLEGE

General Principles Governing Enrolment

- 1. A student is considered to be enrolled when he or she is placed on the Admission Register (ERN) of Wyndham College. A student should be enrolled in one school only at any given time.
- 2. Schools are required to set an enrolment number to cater for anticipated local demand and to seek to ensure that every eligible child has a place at his or her local school.
- 3. The college will continue to monitor, and discuss with DoE, enrolments over the next 5 years.
- 4. Schools are required to have a written policy which states grounds on which non-local enrolments will be accepted.
- 5. The primary criteria for acceptance of non-local enrolments will include the availability of appropriate staff and permanent classroom accommodation.

Particular Criteria for Enrolment in Wyndham College

- 1. Students attending and graduating from the Years 7 to 10 Nirimba Collegiate Schools (Quakers Hill High School, Riverstone High School, Seven Hills High School) will be entitled to directly attend Wyndham College as local area enrolments for their senior years of schooling.
- 2. Students from the 7-10 Nirimba Collegiate schools who have not achieved Stage 5 RoSA, but are permitted by the Principal to enrol, may be offered a specific pattern of study.
- 3. Students who have been expelled from the 7-10 Nirimba Collegiate schools will not be entitled to directly attend Wyndham College for their senior years of schooling.
- 4. Those students who reside in the designated local enrolment area of any of the Years 7-10 Nirimba Collegiate schools but do not attend any of those schools will be considered as nonlocal enrolments. If they apply to attend Wyndham College they may be selected for placement in accordance with criteria for Non-Local Enrolment (over page).
- 5. Those students who move residence into the designated local areas for any of the Years 7-10 Nirimba Collegiate schools post Year 10 and who apply to attend Wyndham College, will be entitled to attend Wyndham College directly as local enrolments. If an enrolment application is received throughout Year 11 or 12, this will be dependent on the ability of the College to offer a place that meets the student's current Year 11 RoSA or Year 12 HSC curriculum pattern.
- 6. All other enrolment matters relating to Wyndham College will be consistent with current policies as set out in, *Enrolment of Students in NSW Government Schools: A Summary and Consolidation Policy* and with the procedures set out in *General Enrolment Procedures: Implementation document for Enrolment of Students in NSW Government Schools Policy.*

Criteria for Non-Local Enrolment Applications

Other Government High Schools

Students who are not attending a Year 7 to 10 Nirimba Collegiate School and are attending another Local Government High School will not be considered for placement at Wyndham College unless:

- (a) requested by the Principal of their local placement high school and authorised by the Director Public Schools NSW.
- (b) special conditions as determined by the Director Public Schools NSW.

Non-government Schools

Each student's application will be considered on an individual basis subject to vacancies. Students who are attending a non-Government High School will be considered for placement at Wyndham College providing they meet such criteria as:

- completion of an expression of interest form
- provision of supporting documentation (eg academic reports)
- an interview with a Wyndham College Deputy Principal
- proximity and access to the school
- availability of subjects or combinations of subjects
- special interests and abilities
- compassionate circumstances
- structure and organisation of the school
- satisfactory conduct and attitude at their previous school and subject to a risk assessment where applicable

All applications will be considered by a panel and parents will be notified of the outcome.

Discrimination in Enrolment

In the context of the above principles and their applications, which clearly constrain an individual's choice of provision, no person will be discriminated against in enrolment on the grounds of their sex, age, race, religion, ethnicity, disability, sexual preference or marital status.
